Communicating EUDR reference numbers and verification numbers

To support your due diligence process under the EU Deforestation Regulation (EUDR), Holmen Board and Paper will provide reference and verification numbers in two formats: **CSV file through email distribution** and **EDI messages** structured according to the **PapiNet XML standard**.

The Regulation does not prescribe the exact means to transfer those data, but it is recommended to exchange them in electronic format, to make it easy to retrieve the numbers and use them in the due diligence statement (DDS) submission. Here is your information about our data output formats.

CSV File

The CSV file follows [CEPI standard format](#) and will contain information for a package level data for each delivery. The file can be delivered separately alongside with delivery/invoice documents (*Loading Specification* and *Invoice*).

The structure is designed to include the following fields, as per the below sequence:

To facilitate electronic reading of the reference numbers and automation within any company's process, we follow the recommendation and use the following standardised format:

Encoding (utf-8), column separator (;), decimal separator (,).

EDI Message (PapiNet Delivery Message)

For customers using EDI, Electronic Data Interface transfer, Holmen will update the **DeliveryMessage** according to the **PapiNet XML schema**.

The message will include a new element *SafetyAndEnvironmentalInformation*:

- <DeliveryMessage>
 - <DeliveryMessageHeader>
 - <DeliveryMessageLineItem>
 - <PackageInformation>
 - <SafetyAndEnvironmentalInformation>
 - EUDR Reference Number
 - EUDR Verification Number
